## THIRD AMENDMENT TO AGREEMENT FOR SERVICES BETWEEN ADVANCED LIFE SUPPORT PROVIDERS AND JAMES STUBBLEFIELD, M.D.

This Third Amendment (the "Third Amendment") to the Agreement for Services, dated September 5, 2019 (the "Agreement"), is made and entered into this date: \_\_\_\_\_\_, between **James Stubblefield**, **M.D.** an individual, (hereinafter "Medical Director") and the following Advanced Life Support (ALS) Pre-Hospital Providers: **Monterey County Regional Fire District**, **City of Monterey**, a municipal corporation, **City of Carmel-bythe-Sea**, **Cypress Fire Protection District**, a California Fire District and municipal corporation, **Carmel Highlands Fire Protection District**, a California Fire District and municipal corporation, **Pebble Beach Community Services District**, a community services district, (hereinafter collectively referred to as "Providers").

NOW, THEREFORE, in consideration of the foregoing, and the covenants and representations and warranties set forth in this First Amendment, Medical Director and Providers, (collectively, the "Parties") agree as follows:

## A. Paragraph 3 of the Agreement is hereby amended as follows:

**3.** <u>**Term; Completion Schedule.</u>** This Third Amendment shall commence on February 1, 2023, and shall terminate on January 31, 2025, and shall automatically renew on an annual basis thereafter for two (2) additional one-year terms unless notice of non-renewal is given thirty (30) days in advance of the annual renewal. This Agreement may be terminated early only pursuant to the terms of this Agreement.</u>


## **B.** Paragraph 4 of the Agreement is hereby amended as follows:

**4.** <u>**Compensation**</u>. Each Provider agrees to pay Medical Director for Services rendered to Providers pursuant to this Agreement in a total annual amount as follows, which includes \$1,000 for malpractice insurance per Provider per year:

- Fourteen thousand dollars and no cents (\$14,000) from 2023 to 2024
- Fifteen thousand dollars and no cents (\$15,000) from 2024 to 2025
- Sixteen thousand dollars and no cents (\$16,000) from 2025 to 2026
- Seventeen thousand dollars and no cents (\$17,000) from 2026 to 2027

## C. Paragraph 5 of the Agreement is hereby amended as follows:

**5.** <u>**Billing.**</u> Payments by each Provider shall be made to Medical Director in two semi-annual installments of one-half of the annual fee each, payable no later than the 10<sup>th</sup> day of February and August of each year this Agreement is in effect.



**D.** <u>**Remaining Provisions of Agreement.**</u> Except as otherwise specifically set forth in this First Amendment, the remaining provisions of the Agreement shall remain in full force and effect.
