A RESOLUTION OF THE PLANNING COMMISSION OF THE CITY OF CARMEL-BY-THE-SEA APPROVING DESIGN REVIEW APPLICATION (DR 20-350), USE PERMIT APPLICATION (UP 23-158), AND ASSOCIATED COASTAL DEVELOPMENT PERMIT FOR THE CONSTRUCTION OF A 22,443-SQUARE-FOOT, TWO-STORY MIXED-USE BUILDING KNOWN AS "ULRIKA PLAZA" WITH 12 APARTMENT UNITS WITH 9,000 SQUARE FEET OF COMMERCIAL FLOOR AREA, WITH A 15,292-SQUARE-FOOT BASEMENT CONTAINING 28 BELOW-GROUND PARKING SPACES LOCATED AT THE SOUTHWEST CORNER OF DOLORES STREET AND 5TH AVENUE IN THE SERVICE COMMERCIAL (SC) ZONING DISTRICT; APNS: 010-138-021/003

WHEREAS, on May 4, 2022, Henry Ruhnke, of WRD Architects ("Applicant") submitted an application on behalf of Esperanza Carmel Residential LLC ("Owner") requesting approval of Track 2 Design Review application DR 20-350 (Ulrika Plaza) ("Design Review"); and

WHEREAS, on May 31, 2023, an associated Use Permit application, UP 23-158 (Ulrika Plaza) ("Use Permit") was submitted by the Applicant. The combination of the Use Permit and Design Review are described herein as ("Application"); and

WHEREAS, the Application has been submitted for a 16,000-square-foot lot located at the southeast corner of Dolores Street and 5<sup>th</sup> Avenue in the Service Commercial (SC) Zoning District; and

WHEREAS, the Applicant is proposing the construction of a 22,443-square-foot, two-story mixed-use building with 12 apartment units with 9,000 square feet of commercial spaces, with a 15,292-square-foot basement containing 28 below-ground parking spaces; and

WHEREAS, 14 commercial units are presently proposed within the 9,000 square foot commercial shell, however, up to 15 commercial units may be allowed for the site to still comply with the parking requirements (provided adequate water is available for the additional unit); and

WHEREAS, this approval authorizes up to 15 commercial units to avoid unnecessary amendments to the associated use permit in the future; and

WHEREAS, the Planning Commission considered initial project plans in April 2021, March 2022, and October 2022 to give preliminary feedback on the proposed project; and

WHEREAS, in accordance with Carmel Municipal Code (CMC) Section 17.58.030 (Commercial Design Review), the construction of new buildings requires approval of a Commercial Track Two Design Review Approval by the Planning Commission when a Use Permit is also required; and

WHEREAS, a Use Permit approved by the Planning Commission is required for each of the following three entitlements: *Increase in Commercial Floor Area, Commercial Spaces or Business* (CMC 17.14.050), Residential Density 22 du/ac –33 du/ac (CMC 17.14.030), and *Underground Floors* (CMC 17.14.150.A); and

WHEREAS, a Coastal Development Permit is also required in accordance with CMC 17.52.090 (Coastal Development Permit Required); and

WHEREAS, in accordance with CMC 17.52.090.B.2, a track two design review approval shall constitute a coastal development permit for any project subject to review under this section (CMC 17.52.090.B); and

WHEREAS, on July 28, 2023, a notice of the public hearing scheduled for August 9, 2023, was published in the Carmel Pine Cone in compliance with State law (California Government Code 65091) and mailed to owners of real property within a 300-foot radius of the project indicating the date and time of the public hearing; and

WHEREAS, on or before July 28, 2023, the Applicant posted the public notice on the project site and hand-delivered a copy of the public notice to each property within a 100-foot radius of the project site indicating the date and time of the public hearing; and

WHEREAS, on or before August 4, 2023, the meeting agenda was posted in three locations in compliance with State law indicating the date and time of the public hearing; and

WHEREAS, on August 9, 2023, the Planning Commission held a duly noticed public hearing to receive public testimony regarding the Application, including, without limitation, the information provided to the Planning Commission by City staff and through public testimony on the application; and

WHEREAS, the California Environmental Quality Act (California Public Resources Code §§ 21000, et seq., "CEQA"), together with State Guidelines (14 California Code Regulations §§ 15000, et seq., the "CEQA Guidelines") and City Environmental Regulations (CMC 17.60) require that certain projects be reviewed for environmental impacts and that environmental documents be prepared; and

WHEREAS, the Planning Commission found that pursuant to CEQA regulations, the Application is categorically exempt under Section 15332 (Class 32) — In-Fill Developments, and no exceptions to the exemption exist pursuant to section 15300.2 of the CEQA Guidelines as found in Attachment 2 of the associated staff report submitted by the Community Planning and Building Department; and

WHEREAS, this Resolution and its findings are made based upon the evidence presented to the Commission at the hearing date, including, without limitation, the staff report and attachments submitted by the Community Planning and Building Department; and

WHEREAS, the Planning Commission did hear and consider all said reports, attachments, recommendations, and testimony herein above set forth and used their independent judgment to evaluate the project; and

WHEREAS, the facts set forth in the recitals are true and correct and are incorporated herein by reference.
