Each year since 2017 (except for 2020), MPBT has staged 3 community performances of the Nutcracker Ballet over one weekend in early December at the Sunset Center. Combining a youth-driven, locally based, pre-professional production with a locally based performing arts venue has afforded Carmel youth and the local Carmel community an opportunity to fully engage their senses in the music, dance, costumes, lighting, and joy of Tchaikovsky's Nutcracker. For many families, this event has become an annual holiday tradition, and complements the other holiday programming Carmel-by-the-Sea offers. For numerous years, the Nutcracker fills Sunset Center's capacity with sold-out shows. Local children who attend the Kingdom of Sweets Party (a pre-Sunday matinee experience put on by MPBT and held in the Sunset Center) engage with Clara and the Sugar Plum Fairy, as well as other lead cast members, and revel in the beauty, poise, kindness, and confidence of these performers. These traditions and memories last a lifetime – for the dancers and audience members, kids and adults, of our community. Please describe the specific benefit to the Carmel-by-the-Sea community that your project, program, or service will provide. Be sure to include the target population and number of community members that will be served.

In 2023, over 130 boys and girls aged 5-18 participated in the three community performances as well as a Friday morning Free Arts Outreach Community Performance for students from the Salinas Unified School District. The 130 performers (approximately 70% from Tularcitos Elementary, River School, Carmel Middle School, Carmel High School, Stevenson Lower & Middle Divisions, as well as home schooled children living in Carmel), spent their weekends, and for some their weeknights, for almost four months learning their parts, collaborating with others, surprising & supporting their younger dancer buddies through a "buddy program," engaging in outreach support activities (i.e., conducting mini-performances at local schools, making holiday cards for the Community Partnership for Youth), and personally developing their own dance and on-stage presence skills, as well as their confidence and self-esteem. In essence, MPBT provides a safe place for these youth to share their passions, develop their leadership skills, make connections amongst themselves and with their community, and thrive in an environment where they are celebrated for their passions, successes, shortcomings, talents and efforts. Thankfully, Carmel residents and surrounding communities also celebrate the hard work and dedication of these dancers and demonstrate their genuine appreciation by attending the performances and generously giving their thunderous applause as the curtain falls.

Primary Target Population:

- 130+ boys & girls aged 5-18 from various school districts and cooperatives.

 Over 700 students from the Salinas Unified School District (attended a free Friday morning production of the Nutcracker)

- Over 2000 arts patrons from the Carmel & surrounding Monterey County communities (watched one of 3 pre-professional productions)

Secondary Target Population (via MPBT Outreach programs):

 Over 450 students at Community Partnership for Youth (received homemade holiday cards)
 Over 600 students at a few Monterey County schools who see 20-minute excerpts of the Nutcracker during school visits, leading up to the December performances

Please describe how your organization would use the funding awarded, including equipment or * services that would be purchased and why.

Each year, MPBT contracts with the Sunset Center, a local entity equipped to support a professional production, in Carmel-by-the-Sea. Understandably, Sunset Center – as a professional organization themselves – does not negotiate contract rates. Sunset Center costs rose 20% last year and 15% the year prior, challenging MPBT to cover increased venue costs as well as all operating expenses as it recovered from the pandemic. This year, MPBT consciously expanded its fundraising and grant writing efforts to help cover both sets of expenses, as it had to dip into reserves in the initial years out of COVID. As such, if awarded, MPBT would use this grant to help defray a portion of the rising cost of our event venue – Sunset Center.

Nova,

I greatly appreciate you reaching out to seek clarification on MPBT's grant request this year. I had interpreted the "no rent" funding policy as not covering the organization's operating rent for our weekly rehearsals, administration activities, etc. I did not fully appreciate that this meant our performance venue facility fee would also be considered "rent." Thank you for that clarification.

As with last year, our request is exactly for the purpose you mention - offering free attendance to a Nutcracker performance for the youth of Monterey county who may not otherwise be able to attend such a performance due to financial constraints. Our Friday morning performance - Free Arts Outreach Community Performance, allows students from the Salinas Unlifed School District (SUSD) to attend the Nutcracker - a ton cost to them. The Sunset Center facility fee is just one of many costs MPBT incurs to mount this particular performance. Other costs include third-party technology services, guest artist fees, Sunset Center labor & equipment costs, etc. While this year we are not seeking financial aid for some of our performers, we are politely requesting the City Council's consideration to help defray the other expenses needed to hold the Friday morning performance for SUSD.

Each performance of the Nutcracker (removing the Sunset Center Facility Fees only) costs about \$12,500. If all Sunset Center expenses are removed (including labor & technical equipment - lights, sound, etc. - costs), MPBT still spends an additional \$9,000 to make this particular SUSD performance happen. (Please see attached budget for details.) MPBT is pursuing the City Council Discretionary Funding (as well as other grant opportunities) to defare these additional costs so we may continue delighting 700+ students from SUSD with the Nutcracker this December 2024.
