### AMBULANCE PERFORMANCE MEASURE

The performance goal for Code-3 (life threatening emergency-lights & siren) ambulance calls with a response time of 5 minutes or less from dispatch to arrival is 95%. For the month of May 2024 the ambulance was able to meet the performance measure. The response time was 97% with 1 code-3 call over 5 minutes.
