Thank you for your email and for the heads up about the rally planned for next week here at City Hall. We genuinely welcome and encourage people to get involved and speak their minds here. After all, City Hall is the house of the people. I wish you all the best with your gathering. I believe with your vast experience, and the kind words in your email about coming in Love and Peace, you are well suited to lead/organize a rally in a City and it will be successful. In an effort to help your success, I want to offer a few points for the good of the general public that hopefully you can share with your group as the leader/organizer:

- Noise - With a public meeting taking place, please do not disrupt the meeting by making excessive noise. The Carmel Municipal Code (CMC) includes section 2.04.070 "*Council Meetings – Maintenance of Order*" which provides more info on this.
- Blocking sidewalks and streets - Assemblies are welcome and encouraged as long as the group and their actions don't block access to public buildings, sidewalks and streets or impede someone's right to pass. CMC Chapter 12.32 has a lot of good information about conduct on public property that would be useful for you and your group.
- Other ways to have a successful rally - I have included as an attachment to this email, a handy-dandy piece of literature that the American Civil Liberties Union (ACLU) puts out which they call "An Activist's Guide". You probably know most of the stuff in there already, but I like to share it with people interested in activism.

With respect to the proposed sale of art or any other merchandise next week, I can understand the desire to do it, but unfortunately the City Code does not allow for that to take place as you have proposed it and without a permit. CMC Section 17.14.040.T states that "*All retail sales shall be conducted from within a fixed place of business*" with very limited exceptions for certain things, which are enumerated in CMC Section 17.14.070. As you might notice in this list of exceptions, there is an opportunity for "arts and handicrafts" to be sold outside, but only with a permit granted by the Planning Commission, which requires a more formal plan to be reviewed and approved at a public hearing, that shows how the sale will not have adverse impacts to the public or surrounding businesses. If you're interested in having a temporary or pop-up type sale in the future, either in an enclosed space or somewhere outdoors, please let me know and I would be happy to help guide you through the application and permit process. However, the sale component of your event planned for next week cannot be allowed, I'm sorry.

Dear Mayor Potter and City Council Members:

I am writing today to express my opinion that Karen Ferlito should have recused herself from her role on the Ad Hoc Committee and her vote on street addresses because I believe that she was driven by her own self interest and inappropriately used her position to promote an agenda that is beneficial to her. In other words, Ferlito has an obvious conflict of interest. Her own words to an interviewer from the Canadian Broadcast Corp. tell the story.

In a Canadian Broadcast Corp interview with Ferlito dated Jan. 22, 2024, the author says: "Ferlito says her place can be hard to find, and she worries about what would happen if she needed an ambulance or fire truck". (Philip Drost · CBC Radio · Posted: Jan 22, 2024 2:52 PM PST | Last Updated: January 2). Ferlito's own words in this interview reveals her own personal stake in this street address issue.

Ferlito continues to say in this Canadian Broadcast Corp. interview that "I have one woman that has written to me that, you know, unless she stands out in the street and waves down a delivery service, they can't seem to find her, said Ferlito." (Philip Drost · CBC Radio · Posted: Jan 22, 2024 2:52 PM PST | Last Updated: January 2). This is stunning to me, that she can only quote from "one" woman as of January, 2024.

Further promoting her personal agenda in this interview, Ferlito is dismissive of a CRA Survey, which showed that: "According to a survey by the Carmel Residents Association, 59 per cent of respondents said they don't want numbers on their property". (Philip Drost · CBC Radio · Posted: Jan 22, 2024 2:52 PM PST | Last Updated: January 2). Ferlito saying that "residents' association survey doesn't really represent the city, as it only heard from about 18 per cent of its members". (Philip Drost · CBC Radio · Posted: Jan 22, 2024 2:52 PM PST | Last Updated: January 2). Ferlito is essentially minimizing and marginalizing 59% of the CRA members because it does not fit her narrative.

There is a clear perception among concerned and angry residents, post 3-2 vote, that she spearheaded the ad hoc committee of "one" for her own personal benefit. There was a built-in conflict of interest

throughout the process of her committee, the violation of the Brown Act in her lack of proper and clear noticing to the public and with her final vote.

Mayor Potter and City Council Members,

I believe the decision you made on July 9, 2024 concerning the street number addresses is a clear violation of the Brown Act given the vague and confusing purpose of the noticed agenda item. However, perhaps even more concerning, your decision also violated the California Environmental Quality Act (CEQA).

As I said on the record at the July 9th City Council meeting concerning our Hofsas House Appeal, you've established a "disturbing pattern" of misusing CEQA, ignoring it altogether, and incorrectly exempting projects from it. The street addresses further exacerbates this disturbing pattern. As I said, you've established "a CEQA-free zone in Carmel."

You already violated CEQA by exempting the Hofsas House hotel. Then you violated it again when you rejected our Appeal challenging the exemption. But the facts that Mr. Neal Kruse and I presented, and the statute, are very clear and you



should have prepared an Environmental Impact Report (EIR). We are not done seeking intervention on this matter.

You also violated CEQA by adopting the Housing Element, erroneously claiming there is no potential for significant adverse impacts resulting from the authorized new 349 housing units crammed into our dense and compact one-square mile village. In this regard, you approved a flawed Mitigated Negative Declaration instead of preparing an EIR.

In doing so you didn't assess the potential for foreseeable primary and secondary adverse effects from removing the two highly used public parking lots, and didn't address or consider the cumulative effects of construction activities associated with the 349 housing units and the Hofsas House, the Ulrika Plaza, and the JB Pastor Building. Unfortunately, you also refused to apply the Surplus Land Act, never designating the parking lots as "surplus" pursuant to the statute before offering them up to the State for housing. But those parking lots are highly used and critically needed as parking infrastructure, and therefore not surplus in the first place.

You also violated CEQA by approving the Ulrika Plaza project. In doing so you exempted it from appropriate CEQA review, and facilitated a 7-year debacle of a massive hole in the ground, and structural damage to the neighboring historic Carmel Art Association building and the Carmel Foundation Apartments for low-income seniors. Unfortunately, you're currently in the process of violating CEQA for the proposed update of the Forest Plan, and for the JB Pastor Building permitting process.

Now you're at it again with your July 9th decision to require street numbers. (I note that Mayor Potter and Councilwoman Dramov voted "No", and I, and others, sincerely thank you for taking that stand.)

That vote was a "discretionary decision" that has the "potential for a direct" and "foreseeable indirect physical change to the environment." Specifically, it will result in a physical change to every house and business in Carmel, and foreseeably result in other physical changes such as more lighting requirements to illuminate the numbers, mail boxes, and the closing of our historic post office. These changes have potential significant adverse impacts that should have been assessed under CEQA before you made your decision. The historic nature of the village, and that of the many historic structures in it, certainly should have been considered pursuant to CEQA.

Instead, you rushed your decision and based it on false claims and scare tactics about long emergency response times, and on some residents who want more convenience. But the response time in Carmel is only 3 1/2 minutes, which is about half the national average for urban areas, and frankly, anyone who can't live in Carmel with an inconvenience should move. The history, character, independence, and uniqueness of this village is much more important than those who can't deal with inconveniences. It's disturbing that you never legitimately

justified the “need” for street number addresses in the first place.

I request that you reconsider your decision, and reassess the basis for such a decision in light of the California Environmental Quality Act. If you somehow justify why street numbers are actually needed beyond convenience, then you must fully assess the potential significant adverse impacts pursuant to CEQA before deciding to proceed.

I am unable to attend the meeting.  
**House numbers need to be uniform and subtle and used for deliveries ONLY. E.g. a small carmel stone with a number at the street curb in front of each house. No installation of mailboxes! We should not allow installation of mailboxes, so therefore, mail will continue at the post office on Dolores & 5th.** (This is what I would say if I could attend the meeting.
