Dear Honorable City Council Members,

We are among many of the Monterey residents who are urging you to stay strong and deny these residential cell towers in beautiful Carmel. Your own wireless ordinance strongly supports the denial of these cell facilities. They will only bring ruin to Carmel's beautiful nature setting and the historical charm with its unique buildings and homes. The concerns for cancer is also on the rise with this microwave radiation equipment in neighborhoods and near schools.

In addition, your city in particular has every right to deny them, as it is a high fire forested neighborhood with lacking evacuation routes for its population in a fire disaster. We had sent a detailed fire information report to the Planning Commissioners not long ago warning of the increased fire risks that will come along with this microwave radiation equipment in an already high fire neighborhood with the most flammable type trees. It is a fact that global warning is increasing the fire risks in California and dehydrating the trees. Take a good look at your evacuation routes with narrow streets, some dead end, and with thick foliage. Scary to think of the gridlock that can easily happen for your residents in a forested neighborhood with an exiting fire disaster. Any dehydrated tree could fall and block one of the limited exits and further complicate a disaster. Hot debris could be flying near vehicles in a chaos of gridlock trying to escape. This is not an exaggeration. Your town is simply at an environmental disadvantage and this added Microwave Cell Facilities will definitely increase fire risks, intensify any fire, and will be placing your residents in increased danger. You simply cannot place this kind of life threatening responsibility on your wonderful fire fighters who are only human themselves.

We are writing in support of our City Planning Commission's <u>denial</u> of the Design Review, Use, and associated Coastal Development Permits for "the installation, operation and maintenance of five wireless communication facilities on existing or replacement PG&E utility poles located within the public right-of-way in the Single Family Residential (R-1) Zoning District."

We are nearby owners and residents of one of the proposed areas of installation (Site 3) and oppose modification of existing or additional cell towers in our quiet, picturesque Carmel-by-the-Sea neighborhood. We have clear and complete cell coverage, so in addition to the lack of need for any "improvements," we oppose new equipment for the unsightly aesthetic it will add, as well as the potential negative health effects of unwanted increased cellular exposure.

Moreover, Carmel-by-the-Sea is unique—folks from all around the world come for the unmatched peace of its surrounds, the beauty of the sea, and quiet of our neighborhoods. Residents and tourists alike do not come to Carmel to be plugged in more, but to escape life's pressures and be reminded of the importance of authentic interpersonal connection. The proposed wireless expansion does nothing to move us toward this goal.

Please, do not bow to the pressure of this appeal. We absolutely do not have a need for more powerful or plentiful wireless communications facilities in our residential neighborhoods.



Thanks for the info below. Unfortunately I am not here on September 10 to attend the hearing. But I want to stae my reasons for rejecting the extensions of poles and attachments of wires, attenas etc. on these in our neighbourhood:

- if Verizon is allowed to go ahead with the proposal than anybody else can load up these poles (they are ugly enough already). Xfinity has already installments on our poles in residential areas. More to come? Enough is enough.
- it really disturbs the character of the residential area of Carmel
- we receive here only 3 G, 5 G is a long way out into the future for the residential district of Carmel
- I have not heard anybody in our neighbourhood complaining that they can't receive or make outgoing calls or e-mails.
- put the requested installations either near the highway, commercial shopping centers or downtown Carmel. I am sure you don't want to have them next to the Town Hall, either.
- For the future: What about thinking to put these underground, like you have in the commercial district of Carmel by the Sea and part of Junipero Street? That would be progressive and a useful use of our tax dollars.

Please make my comments available to the counsel members who will decide on this project and keep me informed about the decision etc.


