#### **Citywide Parks & Forestry**


New and ongoing work -

- Landscape maintenance tasks, previously performed by a contractor, have been divided up amongst staff. This approach is working well. Maintenance work is the focus on Mondays and Fridays with larger tree jobs being executed in the middle of the week.
- New rigging equipment required for staff to safely perform larger tree work that was previously contracted out has been purchased and delivered.
- Damage caused by bark beetles has slowed and fewer pines are in decline.
- Older oaks continue to struggle from damage caused by California oakworm.
- Joni L. Janecki & Associates has been retained by the home owners on the eastside of San Antonio to work on the San Antonio pathway hedge replanting design.

Notable tree failures - There was one failure that was addressed in July.


 Another cypress limb at Alta Avenue and Junipero Avenue. This is from a second strike from a moving company tractor trailer.


