EXISTING CONDITION: TREE REPLACEMENT COMPLETED PER THE BY DEERING DESIGN DATED $3 / 8 / 2020$ EXISTING PLANTING INCLUDES ONE (1) $12^{\prime}-0^{\prime \prime}$ TALL QUERCUS AGRIFOLIA OAK SEEDLINGS, MISCELLANEOUS HORTICULTURAL PLANTS \& NON NATIVE SPECIES INCLUDING EHRHARTA ERECTA, BOSTON IVY, \& HEMLOCK WEED CONTROL WAS COMPLETED FOR INVASIVE AND NON-NATIVE SPECIES AND IS ONGOING.

WEED CONTROL WA COMPLETED FOR INVASIVE AND NON NATIVE SPECIES AND IS ONGOING.
