#### **ANNOUNCEMENTS**

City Administrator - Announced that the Mayor will be hosting a Community Listening Session tomorrow evening at 5 pm to receive public input on the Police Building Project, and announced that there are still spots open to sign up for the Police Station Tour.

City Attorney - No reportable action from yesterday's closed session.

Mayor Pro Tem Richards - Attended a great concert Van Morrison at the Sunset Center, good job Carmel High Basketball.

Councilmember Ferlito - Announced she will be attending a half day workshop at ReGen and reminded the public to make sure batteries are not placed in the trash and to place them in a bag on top of the trash can for pick up.

Councilmember Dramov - Announced that there will be a City Council Priorities Workshop meeting on March 28, 2024, at the Sunset Center and invited the public to attend and give their input on Council priorities.

Item 1 - Receive an update on Car Week 2024

Ashlee Wright, Library and Community Activities Director, gave a presentation on events planned for Car Week in August 2024, provided an overview of parking stall permit changes, and summarized plans for traffic calming measures. Ms. Wright answered questions from Council. Police Chief Paul Tomasi said that two decibel measuring devices have been ordered to enforce car exhaust noise complaints.

Council received the update on Car Week; no action was taken.

**Item 2** - Fiscal Year 2023-2024 Mid-Year Budget Report and Resolution 2024-022 Approving FY 2023-2024 Adopted Budget Amendments

Acting Assistant City Administrator Brandon Swanson introduced the City's new Finance Manager, Subbhada Winer, and expressed gratitude to Senior Accountant Jane Hogan for her interim role as acting Finance Manager. Finance Manager Winer presented the mid-year budget report for July to December 2023, along with proposed budget amendments for Fiscal Year 23-24 and their corresponding revenue sources.

Public Comment: Melanie Billig Tasha Witt

Councilmember Baron requested inclusion of tree replacement costs in the FY 24-25 budget and a comparison of projected TOT and property tax revenue with actual amounts received. Councilmember Ferlito raised concerns about utility lines on trees, advocating for action against companies responsible and replanting upper canopy trees on streets without power lines. Mayor Pro Tem Richards suggested inviting the City Forester to a future meeting for an update on tree replacement procedures in the urban forest.

Motion by Councilmember Baron to adopt Resolution 224-022, seconded by Councilmember Ferlito, and approved 5-0-0-0 by the following roll call vote:

**Item 3** - Receive a presentation on the proposed Fiscal Year 2024/25 Capital Improvement Program and Five-Year Capital Improvement Plan, and provide direction to staff

Public Works Director Bob Harary gave a presentation on the 15 completed CIP projects in Fiscal Year (FY) 23-24, 4 projects to consider modifying or cancelling, review of 14 carry-over projects, and initial review of 12 potential new CIP projects for FY 24-25, and introduction of an updated 5-year CIP plan.

Councilmember Dramov asked if Public Works could come back in April with a list of all of the City's owned buildings and what the deferred maintenance is for each.

City Administrator Rerig addressed questions from the public and discussed the long-term costs of hiring staff versus using consultants for specialty projects.

Councilmember Dramov voiced concern for staff capacity for handling multiple projects simultaneously. Councilmember Baron proposed hiring a consultant or staff member or a consultant to manage CIP projects, as well as reallocating funds from Sunset Center Portico project to more critical projects like beach stairway repairs. He also raised concerns about increasing drainage repair costs and requested updates on the Library Master Plan. Additionally, he suggested replacing the use of concrete with asphalt at Ocean and Junipero intersection for a more sustainable approach and to repair more streets.

The Council paused the CIP discussion to consider continuing it at a future special meeting due to time constraints and to ensure adequate time for public hearings on remaining agenda items.

Motion Mayor Potter to continue CIP item to a special meeting on March 26th at 4:30 pm, seconded by Councilmember Baron, and approved 5-0-0-0 by the following roll call vote:

**Item 4** - Receive an Update on the 6th Cycle Housing Element (2023-2031), Second Draft Mid-Review Comments from the State Department of Housing and Community Development (HCD)

Principal Planner Marnie Waffle gave a presentation on the 6th Cycle Housing Element Revised Second Draft. She summarized the timeline to adoption, provided an overview of comments received from HCD, summarized the new programs included, and highlighted other amendments.

City Administrator Rerig addressed several questions brought up by the public, clarifying that that the city doesn't have any current "surplus" land, there is land owned by the city suitable for housing without eliminating its current uses. Ms. Waffle clarified the RHNA were able to be met by including city owned sites as potential housing locations. Acting Assistant City Administrator Swanson answered additional questions from Council.

Mayor Pro Tem Richards, a housing element ad hoc member, emphasized the intention to distribute affordable housing units across the city. He also cited repercussions faced by other California cities for non-compliance with state mandates. Councilmember Ferlito stated that the Housing Element is a living document that can be amended as needed and emphasized the need for adoption by April 15th to retain local control and avoid legal challenges. She responded to parking concerns, emphasizing that inclusion of structured parking will be required for potential housing developments.

Councilmember Dramov voiced agreement with public concerns regarding housing developments in Sunset Center parking lot and Vista Lobos, as well as the preservation of open spaces. Councilmember Baron noted public resistance to rezoning R-1 districts or permitting 3rd story buildings to disperse RNHA allocations, prompting inclusion of city-owned sites to meet requirements.

Council provided the following consensus direction to staff to make the following changes to the housing element:

- Program 1.1.B: City owned Sites Push date to release RFP farther back than Fall 2024.
- Program 1.1.E: City Partnership with Carmel Foundation to Develop Affordable Housing -Change language so that by 2027 the city isn't absorbing lower income units from a specific site it should apply to all sites.
- Program 3.1.F: Expedited Processing Procedures keep in the requirement of using story poles but will consider "alternative" methods that achieve the same outcome of story poles.
- Language about the Surplus Lands Act take out the word "available", and if it is made available, we confirm adherence to the law.

#### **PUBLIC HEARINGS**

Councilmember Ferlito emphasized that the Council retains discretion in determining the fulfillment and equity of finding #5, asserting no change in rules.

#### City Council Meeting of February 6, 2024

• Meeting cancelled due to the storms. Items deferred to the March 4<sup>th</sup> and 5<sup>th</sup> meetings.

#### Forest and Beach Commission Meeting of February 8, 2024

- Announcements included:
  - The City Forester will summarize the impacts from the significant February 4<sup>th</sup> storms under the City Forester's Report.
  - Police Chief Tomasi will attend the meeting next month to review the criteria of when we need to close the beach, coordinating emergency services with the County, and FEMA funding.
  - At the February 15<sup>th</sup> Climate Committee meeting, the consultants preparing the Coastal Engineering Study, Phase 1 will be presenting the results of sea level rise impacts to the shoreline and vulnerable infrastructure. Same presentation will be made at the March F&B Commission meeting.
- Commission approved the proposed project by the Leadership Carmel Class of 2024 for enhancements to the overlook along the Scenic Pathway south of Eighth Avenue, subject to issuance of an encroachment permit by staff.
- City Forester presented the results of one of the technical studies that comprises the Urban Forest Master Plan (UFMP), regarding the Tree Canopy and Land Cover Assessment. This included a summary of the 9,875 City-owned trees that were inventoried, assessed, and geo-located.
- City Forester gave a live demonstration of the TreeKeeper computer program in which all City trees are mapped. Each tree is linked to their attribute data, current health, and ties to any permits.
- The City Forester presented the Forester's Report for January 2024 which included the preliminary impacts of the February 4<sup>th</sup> storm. Impacts included 106 tree incidents, 43 trees fell, 8 trees in active failure removed, 50 large limbs, power lines down in 4 locations, and 12 homes impacted.
- The Public Works Director presented the Public Works Department Report for January 2024.

#### Climate Committee Meeting of February 15, 2024

- Consultants with Integral, Corp., who are completing the Coastal Engineering Study, Phase 1, presented their technical findings of Task 3, Shoreline and Beach Erosion Exposure Modeling, which included an overview of sea level rise impacts to the shoreline over the next 75+ years, and Task 4, Coastal Hazard and Sea Level Rise Vulnerabilities. Presentation is available on the City website under <a href="https://ci.carmel.ca.us/public-works">https://ci.carmel.ca.us/public-works</a>.
- Staff presented updated project tracking spreadsheets for Climate Adaptation Plan and Climate Action Plan projects.

#### Traffic Safety Committee Meeting of February 28, 2024

• Based on recent pruning to improve sight visibility at Santa Rita Street at Fourth Avenue since the last TSC meeting, denied a request for a 4-way stop controlled intersection.

- As a follow-up to the last meeting's review of trucks using Junipero Street to bypass the designated San Carlos Street truck route, between Eighth and Thirteenth Avenues, the Police noted that 0 to only 6 trucks per day were counted over the course of nearly a week, and most of those trucks were local delivery trucks. Public Works noted that there is adequate signage for trucks to follow the designated truck route although a couple of signs need to be replaced. While no further action required at this time, the TSC will review this item following paving along San Carlos, scheduled for April, to ensure no change in truck routing behaviors once San Carlos is a shared truck/bus/bicycle route.
- Continued a request for a "Children at Play" sign(s) on Monte Verde Street, between Eighth and Ninth Avenues, pending more information from the Golden Bough Theater regarding anticipated children attending events following its renovation, and the possibility for the Theater to provide a traffic guard.
- Denied a request for a 4-way Stop controlled intersection at Camino Real and Ninth Avenue.
- Denied a request for additional Stop signs along San Antonio Avenue, between Eighth and Thirteenth Avenues, noting that San Antonio is an emergency access route, and that the intersecting streets are T-intersections.
- Approved a request for No Parking post(s) on the east side of San Antonio Avenue just north of Eleventh Avenue, due to parked vehicles obstructing the travel lane and reducing visibility.
- Approved a request for No Parking post(s) on Dolores Street 2 southeast of Vista Avenue, across from the Stevenson School driveway.
- Approved a request for a convex mirror to be mounted on a power pole at the southwest corner of Santa Fe Street and Mountain View Avenue.
- Acknowledged Public Works' request to allow for gaps in the split rail fence along the Junipero Street median, between Ocean and Seventh Avenues, rather than continuously repairing fences damaged intentionally by jaywalkers.

#### Administration

- Prepared staff report for the March 5<sup>th</sup> Council meeting regarding the first review of the Capital Improvement Program for Fiscal Year 2024/25. The report identified 15 capital plus 14 operating budget-funded projects completed in FY 2023/24, collectively valued at \$3.3M, four projects recommended to be canceled or modified, 14 active projects to be carried over into FY 2024/25 with a total value of \$8.1M, 6 carry over, "shovel ready" projects that require supplement funding of approximately \$1.7M for construction, 6 new equipment and IT purchases valued at \$0.5M that could be funded by the Vehicle and Equipment Fund, and 12 potential new capital projects, valued at \$2.9M and funding from the Capital Fund. The report makes clear that the list of needed projects may exceed funding availability and contributes to the current one-year backlog in completing existing projects.
- Updated the preliminary 5-Year Capital Improvement Plan.
- On February 22<sup>nd</sup>, a meeting was held with the California Coastal Commission (CCC) regarding repairs that are needed along the shoreline that are urgent and longer-term projects, as well as repairs needed for beach access stairs, rock revetments, and seawalls. The CCC advised the City that certain repairs above the mean high tide line could be completed by City forces under a City-issued Emergency Coastal Development Permit.
- Subsequent to the meeting with the CCC, Public Works managers inspected all concrete and wooden beach access stairs and prepared a "Game Plan" to repair and open the concrete stairs located at Eighth, Tenth-South, Eleventh, Thirteenth, and Santa Lucia Avenues. This effort will be followed by repairing the wooden stairs at Martin Way. Remaining stairs require structural engineering/construction measures and more sand to return to the beach to eliminate the steep drop off at the stair bottoms.
- On February 21<sup>st</sup>, the Public Works Director participated in a City Directors on Point event at the Women's Club that was sponsored by the Carmel Residents Association.
- On February 27<sup>th</sup> and 29<sup>th</sup>, the City Forester, Public Works Superintendent, Environmental Programs Manager, and Project Manager participated in public Development Workshops to present information on tree permits, encroachment permits, storm water quality measures, and drainage requirements.
- Coordinated with Leadership Carmel Class of 2024 to guide submittals required for staff to process the encroachment permit associated with the Scenic Pathway Overlook Legacy Project approved by the Forest and Beach Commission.

- For the Maintenance Worker vacancy, 10 candidates were interviewed by an external panel, and the top four finalists are scheduled for a final departmental interview in early March.
- PW managers met with colleagues in the Community Planning & Building Department to continue to review and develop new process improvement strategies.
- Updated a list of 50 active projects and key task assignments for Public Works staff for the months of February through June 2024.

#### **Carmel Cares and Other Volunteer Groups**

- For the Ocean Avenue Median Islands Landscaping Project, Carmel Cares prepared landscaping plans, cost estimates, and PowerPoint slides to present the landscaping project to the Forest and Beach Commission for final approval at the March 14<sup>th</sup> meeting.
- Carmel High School Interact Group students worked with Carmel Cares volunteers to do extensive weeding and clean up at the Forest Theater native plant garden.
- "Downtown Detail" volunteers continued to clean and improve the downtown area.
- "Median Minders" volunteers continued to improve medians across the Village.
- The Friends of Mission Trail Nature Preserve coordinated with Environmental Programs staff regarding new, donor-funded MTNP entry signs. Sign designs will be submitted to the Forest and Beach Commission and Planning Department for approval in April.

#### **Environmental Programs**

- For the Coastal Engineering Study, Phase 1, received and accepted the consultants' technical report covering Tasks 3, Shoreline and Beach Erosion Exposure Modeling, and Task 4, Coastal Hazard and Sea Level Rise Vulnerabilities.
- Prepared staff reports for the February 15<sup>th</sup> Climate Committee meeting associated with the Coastal Engineering Study Tasks 3 and 4, and regarding project tracking spreadsheets for projects identified in the Climate Action and Climate Adaptation Plans.
- For the Coastal Engineering Study, Phase 2, Amendment No. 1 to the PSA with EMC Planning/ Integral/Haro Kasunich was finalized for a fee of \$450,000. A staff report and resolution were prepared for Council to approve this LCP Grant-funded Amendment. This item was postponed from the February to March 4th Council meetings.
- CalRecycle representatives visited Carmel and performed a random, "lid flip" audit of trash, recycling, and organics containers in the Village. Happy to report that Carmel is "ahead of the curve" in regards to proper sorting of trash, recyclables, and organics in the waste containers.
- Participated in a tour of organizations awarded Edible Food Recovery Program Grants who are redirecting unconsumed, edible food from the landfill, where it breaks down into Greenhouse Gas, to benefit people in need.
- Confirmed 37 organizations and vendors to participate in the second annual Earth Day, to be held in conjunction with Arbor Day and Community Day, on April 20, 2024. Prepared staff report for the March 14<sup>th</sup> Forest and Beach Commission regarding this event.
- Friday Letter public service announcements included:
  - E-waste disposal information
  - o Link to a new television commercial regarding proper Pet Waste Disposal
  - Packaging used batteries in bags for recycling pickup, outside of the waste stream
  - Rain barrels
  - Save the date May 4<sup>th</sup> for "Snapshot Day" for volunteers to collect water quality samples

#### **Facility Maintenance**

- For the Sunset Center Carpenter Hall Heater Replacement Project (CIP), a Purchase Order was issued, a mechanical building permit is being processed, and parts were ordered.
- As part of the ADA Upgrade Project Year 6 (CIP), ADA-compliant railings for the Harrison Memorial Library were fabricated and galvanized by the vendor. Installation scheduled in late March.
- Received additional quotes from electrical contractors to rebuild the electrical panel next to the Ocean/Juniper Christmas tree for safety reasons.

- Although the annual fire system inspections were completed last fall, the last of the identified, remedial repairs to sprinkler systems were completed in February.
- Following a storm, a drain was clogged in a flat portion of the Sunset Center roof, causing water to leak into the electrical room below. Thanks to Monterey Fire who helped us access the high roof using their ladder truck so we could clear the drains.
- At the request of the Library, began to evaluate the capability of the Park Branch Library emergency generator to be able to backup additional electrical circuits, and possibly heating, to accommodate storm shelter facilities during power outages.
- In the Sunset Center north parking lot, a rusted light pole failed, and a replacement pole was ordered.
- At the Del Mar restroom, replaced rusted rollup door components housing the beach ATV vehicle.
- At the Norton Court parking garage, repaired a parking exit gate, and assessed options to replace the failing security access system that is reaching the end of its useful life.
- Troubleshooting and repairs were completed to prevent short-circuiting of Police parking lot lighting.
- Attended the National Fire Protection Association Fire Pump class.

#### **Project Management for the Capital Improvement Program**

#### 4 Leaf Projects:

- Similar to the Police Building Project public meeting on January 25<sup>th</sup>, the Council Ad Hoc Committee held a second public meeting on February 1<sup>st</sup> to seek additional community input on the building condition assessment, Police space programming needs, and preliminary concepts for potentially relocating the Police Station to a new site or renovating the building in the current location.
- Amendment No. 1 to the Professional Services Agreement with 4 Leaf consultants was outlined.
  Three of 4 Leaf's four previously-assigned projects will officially end, and a Notice to Proceed will be
  issued to authorize \$10,180 for additional services associated with the Police Building Project using
  available supplemental services funds.

#### Ausonio, Inc. Projects:

- Elevator Service Company decommissioned the Park Branch Library Dumbwaiter in record time.
  The contractor also permanently sealed off the dumbwaiter shaft. Notification was also made to the
  State Department of Industrial Relations/Elevator Unit to release the City of its maintenance
  obligations for this unused dumbwaiter. A letter was drafted to terminate our costly maintenance
  contract with Otis Elevator.
- For the Sunset Center North Wing and Harrison Memorial Library Exterior/Interior Painting Project, the construction kickoff meeting was held with the contractor, Color New Co., and technical submittals and encroachment permits were processed. An \$85,000 deductive Change Order was executed reflecting significantly-reduced interior painting in the library. Painting to begin at Sunset Center in late March.
- Staff is reviewing 90% complete contract documents for re-bidding the City Hall Roof Replacement Project. This Project will be "shovel ready" for bidding in July should additional CIP funding be allocated for construction.
- For the Sunset Center Retaining Walls Repair Project and San Antonio Walkway Repair Project, Second to Fourth Avenues, ZFA Structural Engineers performed site visits and are developing the 30% design drawings for both projects for City review in early March.
- For the Sunset Center Portico Design Project, Ten Over Studio submitted three portico concept designs and renderings. The project team will discuss these options in early March and prepare a preliminary cost figure for potential FY 2024/25 CIP funding.

#### Wallace Group Projects:

 For the FY 2022/23 Concrete Streets Repair Project, additional meetings were held with BKF Engineers who are incorporating the final 95% review comments, generated by Wallace Group and staff, into their final construction plans, specifications, and cost estimates. Shovel-ready contract documents will be ready well in advance of forecasted construction funding.

- For the FY 2023/24 City-wide Paving Project, Wallace Group submitted the 30% design package and an associated cost estimate of \$1.7M. 30% plans are under review while the consultant begins to advance the project design plans to 60% complete.
- For the Shoreline Infrastructure Repair Project, reviewed a second draft Request for Proposal to hire an engineering firm with shoreline expertise. Continuing to resolve issues including environmental services scope, options for beach stair repairs, and availability of prior reports.

#### Additional Capital Improvement Projects:

- For the \$1.14M, FY 2021/22 City-wide Paving Project, Monterey Peninsula Engineering raised manhole covers to the grade of the new asphalt overlays, constructed asphalt berms, and installed thermoplastic legends and markings along Junipero Street, Third to Fourth Avenues, along Santa Fe Street, Fourth to Fifth Avenue, and at the Junipero/Camino del Monte Intersection. Sidewalk repairs were delayed due to weather and delivery of permeable pavers, but are scheduled for March.
- For the Mission Trail Nature Preserve (MTNP) 3 Drainage Projects, which includes drainage piping
  near Rio Road, an 85-foot boardwalk over a bog, and reconstruction of a large swale, the contract was
  advertised for construction bids. Fourteen contractors attended the mandatory pre-bid meeting and
  site tour. Bid opening is on March 19<sup>th</sup>. Also, met with Dudek to significantly down scope their
  environmental monitoring proposals for during and post construction as required by the regulatory
  agency permits. A revised proposal is forthcoming.
- For the 4 City-wide Drainage Improvement Projects, Denise Duffy & Associates and staff performed site assessments for discharging into the MTNP and Pescadero creeks, and allowing the project to proceed with two Notices of Exemption under CEQA. Contact was also made with a property owner at the south end of Santa Fe Street, south of Eighth Avenue, who supports the City's acquisition of an easement through a landscaped area, to allow for drainage line to discharge into the MTNP creek.
- For the PG&E Rule 20A underground utility district project, the Council Ad Hoc committee and staff toured the two proposed underground district locations: Del Mar parking lot west of San Antonio Avenue, and along the MTNP Willow Trail for power lines servicing homes located along Ridgewood Road.
- Met with Carmel Area Wastewater District staff and their design and environmental consultants, who
  are working on their upcoming Scenic Road Sewer pipe bursting project, to coordinate environmental
  documentation processing and minimize construction impacts to the City.

#### **Street Maintenance**

- During and following several storm events in February, cleared out storm drains, picked up fallen branches and tree debris piles, and stockpiled additional sand for sand bags.
- Beach access stairs between Eighth Avenue south to Martin Way continue to be temporarily closed.
   Signs and barricades were replaced as needed.
- Filled a number of street potholes that resulted from rain events, and performed supplemental street sweeping.
- Continued making priority sidewalk repairs based on the recent Annual Sidewalk Survey Update.
   Also began grinding of sidewalk uplifts.
- Installed several more ribbon-style trash and recycling containers. A total of 20 of the 30 recentlypurchase containers have now been installed.
- Ordered a new Ford Mustang Mach 3 EV vehicle for Police administration use.
- The two old forestry trucks were sold at public auction for \$6,400.


#### Forestry, Parks, and Beach (Forester's Report)

- Status of Davey Resource Group (DRG) development of the Urban Forest Master Plan (UFMP):
  - o The first draft of the UFMP was expected in December, but has been delayed and is expected in March.
  - o The UFMP technical report regarding the Tree Planting Palette will be presented to the Forest and Beach Commission and Steering Committee on March 14th.

- o Coordinated with Commissioner Brezoczky regarding coding of information submitted under the UFMP Community Survey to better distinguish input from Carmel residents versus input from respondents from adjacent geographic areas.
- In February, Forestry crews picked up 19 piles of storm-damaged trees and branches, removed 20 fallen, dead or hazardous trees, and pruned 7 trees. Storm cleanup is still ongoing. No new city trees were planted due to the urgency of storm recovery.
- The intense storm in early February brought on a mass of communication from residents seeing over 300 calls and/or emails come in. 224 "tickets" were resolved, but due to staffing challenges, 863 tickets remain outstanding, including correspondences prior to the storm.
- Predominantly as a result of the February 4<sup>th</sup> storm, our 3 tree contractors removed 18 falling trees and pruned 15 trees with broken hanging branches determined by the Forester to be of imminent risk, under contract Task Orders.
- Landscape maintenance work across the City continues to be fully engaged by Town & Country.
- Purchased electric chainsaw in first step to electrifying tools for tree crew.
- Began to transition tree permit intake processing from the Community Planning and Building counter at City Hall over to the Public Works/Forestry office. Cross training underway with an official transfer date scheduled in March.







**SUBJECT:** February 2024 Check Register Summary

#### RECOMMENDATION:

Approve the check register for February 2024.

#### BACKGROUND/SUMMARY:

The check register is a financial report generated from the City's financial system (**Attachment 1**). It categorizes checks by the responsible department or function, providing essential information such as the check number, vendor name, purchase description, check issue date, and the check amount.

Per the California Supreme Court's decision in the case of Los Angeles County Board of Supervisors v. Superior Court (Dec. 29, 2016) (2016 WL 7473802), the check register excludes the specific invoice payments for legal services incurred for pending and active investigations, pending and active litigation, as well as recently concluded matters. The Supreme Court has ruled that these specific invoices are protected under attorney-client privilege and therefore are not subject to disclosure under the Public Records Act.

As a supplement to the check register, staff have included information about the contract balances for vendors who received payments during the month of February 2024. This data can be found on the last page of the report.

The check register provides valuable insights into the City's financial transactions, ensuring transparency and accountability in our financial operations. The exclusion of certain legal services payments adheres to the California Supreme Court's guidelines, safeguarding attorney-client privilege. The contract balance information further enhances our financial transparency.

#### FISCAL IMPACT:

The check register summary for February 2024, totals \$912,828.23.

#### PRIOR CITY COUNCIL ACTION:

Council ratified the December 2023 and January 2024 check registers at the March 4, 2024 regular meeting.

#### RECOMMENDATION:

Receive a presentation by California American Water Company to introduce the Dolores Street Water Main Replacement Project and authorize issuance of an Encroachment Permit with Special Conditions of Approval.

#### BACKGROUND/SUMMARY:

California American Water Company (CalAm) has completed the design of a proposed water main replacement project along Dolores Street, between Eighth and Santa Lucia Avenues, and has applied for a permanent Encroachment Permit (**Attachment 1**) to proceed into construction.

The Project consists of abandoning in place approximately 3,000 feet of the existing 4-inch diameter water main, and constructing a new, parallel, 8-inch diameter water main which will typically be 3-feet deep. The Project includes upgrading existing and adding two additional fire hydrants, replacing customer water service lines and meter boxes, and installing pipeline appurtenances. All new infrastructure will be located below the ground with the exception of the new fire hydrants. Upon completion of the pipeline, the street will be resurfaced with a slurry seal at no cost to the City. A Project location map is shown in **Attachment 2**.

This water main replacement project is part of CalAm's infrastructure upgrade program to replace aging infrastructure in order to reduce leaks, improve water quality, increase flows for fire protection, and provide better reliability for their customers in and around the project area. Customers will continue to have water service at all times except temporarily when service connections are switched over.

Public Works has reviewed the proposed pipeline construction plans, traffic control plans, and arborist report. The Project design was modified to reduce impacts to existing tree roots by locating the water main further away from the edge of the roadway while still maintaining adequate separation from existing sewer and gas mains that are also in the road right-of-way. No trees will be removed. In addition, the Monterey Fire Department and Carmel Community Planning and Building Department evaluated the proposed fire hydrant locations and spacing, ensuring compliance with current codes.

To minimize impacts to the community before, during, and after construction, Public Works developed 70 Conditions of Approval for the Encroachment Permit which were all negotiated with and accepted by CalAm. These conditions are listed in **Attachment 3**. Key Conditions of Approval for the Encroachment Permit include:

- Provide \$5M general liability insurance coverage
- Provide public notices and signs which display a 24/7 hotline phone number for concerns
- Provide ongoing coordination with Police, Fire, GreenWaste, and others
- Conform to approved traffic control plans
- Provide detour routing around the active construction zones
- Provide local residence ingress and egress at all times
- Confirm to all environmental regulations and mitigation measures
- Provide updated construction schedules to the City
- Coordinate and shutdown, if necessary, during City special events
- Reconstruct any damage to private and public property

At this time, construction is anticipated to begin in May and be substantially completed within four months. CalAm and their engineering consultant, H2O Urban Solutions, will manage construction and oversee the contractor, Monterey Peninsula Engineering. Public Works will ensure adherence to approved traffic control plans, inspect street restoration work, and ensure compliance to the Conditions of Approval. The Directors of Public Works and Public Safety have the authority to immediately shut down the Project if serious problems or safety issues arise.

At the April 1, 2024 Council meeting, Mr. David Pezzini, CalAm's Engineering Project Manager, will provide a presentation describing the purpose of the Project, anticipated construction impacts, and mitigation measures.

#### **ENVIRONMENTAL REVIEW**

The City finds that this Project is exempt from CEQA as it meets the requirements of Section 15302(c) "Replacement or reconstruction of existing utility systems and/or facilities involving negligible or no expansion of capacity". The project is for the replacement of an existing water pipeline within the existing roadway right-of-way. A Notice of Exemption will be filed by the City upon Project approval by the City Council.

#### FISCAL IMPACT:

Based on the length of pipeline replacement, this Encroachment Permit fee is \$13,516.



- Show the location of the main building or edge of the building
- Depict existing and any proposed hardscape in the area of work (driveways, patios, paths, etc.), and note existing and proposed. Include dimensions or widths and call out materials (asphalt, pavers, decomposed granite, etc.)
- Show any areas proposed for staging of construction or demolition materials.
- Show all existing trees with a trunk diameter > 2 inches that are within 10 feet of all work areas. Call out approximate tree diameter and species, if known.

# Right-of-Way Vision Statement

In most neighborhoods, the edges of the public right-of-way (between the road edge and adjacent private property lines) are unpaved. The right-of-way is often left unplanted resulting in an informal character of volunteer plantings, packed earth and pine needles. The right-of-way is also often planted with indigenous species consistent with a forest appearance. Both approaches contribute to a linear green belt appearance that helps to create the "village in a forest" character that defines the City.

The City has adopted clear standards that guide the treatment of the right-of-way in the residential district. These standards can be found at www.ci.carmel.ca.gov or at the Department of Community Planning and Building located at City Hall. Some of these standards include:

- Drought-tolerant, native plants, informally arranged may be permitted.
- Formal plant arrangements with highly colorful flowering plants are prohibited.
- When possible, plantings should not extend to the street edge to allow for off-street parking.
- Paving, gravel, boulders, logs, timbers, planters or other above-ground encroachments are prohibited, except paving for driveways, unless an encroachment permit has been obtained from the City.
- A narrow crushed Decomposed Granite pathway from the street to the property entrance may be allowed without an encroachment permit.

The City is requesting your assistance to ensure that the right-of-way adjacent to your property complies with City standards. If you would like assistance in determining whether the right-of-way adjacent to your property is out of compliance, please contact the Department of Community Planning and Building at (831) 620-2010.

## TRAFFIC CONTROL PLAN - 2018 HANDOUT

## **Objective:**

The objective of a Traffic Control Plan (TCP) is to permit a contractor, utility, or developer to work within the public right-of-way in a safe, efficient, and effective manner while maintaining a safe, uniform flow of vehicle traffic. Additionally, a TCP ensures safe provisions for bicyclists and pedestrians to bypass the construction Work Zone.

TCPs shall be submitted to the Community Planning and Building Department at Carmel City Hall on Monte Verde, between Ocean and 7<sup>th</sup> Avenue, at least 48 hours prior to obstructing any travel to allow for Public Works review and approval and for notifications to the Carmel Police and Fire Departments.

## A TCP must be submitted to the City for approval in the following circumstances:

- 1. Obstructing one or more travel lanes along any arterial street: Carpenter Street, Junipero Street, Ocean Avenue, Rio Road, and San Carlos Street (south of Ocean).
- 2. Obstructing one or more travel lanes along the truck and bus routes (including portions of 2<sup>nd</sup> Avenue, 8<sup>th</sup> Avenue, Carpenter Street, Junipero Street, and San Carlos Street (south of Ocean).
- 3. Obstructing one or more travel lanes along any of the following collector streets: 4<sup>th</sup> Avenue (west of Dolores), 8<sup>th</sup> Avenue, Camino Del Monte Avenue, Mountain View Avenue, San Antonio (Ocean to Santa Lucia), Santa Lucia (east of Dolores), and Scenic Drive.
- 4. Obstruction of one travel lane in a residential area for more than eight (8) hours.
- 5. Obstruction of one travel lane in the business district for more than four (4) hours.
- 6. All proposed road closures.

Note: As an alternative to obstructing traffic, parking spaces can be purchased on a day-by-day basis by contacting the Executive Assistant at City Hall at phone number (831) 620-2000.

## **Traffic Control Plan Preparation Requirements:**

Every TCP submitted for City review and approval must conform to the following guidelines:

- 1. TCP shall reflect actual job site conditions.
- 2. TCPs shall be prepared to scale on 24" x 36" or 11" x 17" sheets.
- 3. Use legible lettering.
- 4. Provide a legend for symbols used.
- Provide a north arrow.

- 6. Provide a "USA/811 Call Before You Dig" warning stamp.
- 7. Lay out streets in proper orientation and label streets.
- 8. Indicate posted speed limits.
- 9. Show and label (or use legends for) existing crosswalks, bike lanes, parking spaces, striping, ADA ramps, berms, and drainage facilities.
- 10. Show existing regulatory signs in the vicinity of the construction Work Zone.
- 11. Identify the type of construction (i.e. install gas line, pave new driveway).
- 12. Indicate location and dimensions of the proposed construction Work Zone.
- 13. Show your proposed equipment/materials staging area, if applicable.
- 14. Note the contractor's business name, address, phone number, and license number.
- 15. Note the name and phone number(s) of 24-hour contact(s) for emergencies.
- 16. Indicate the proposed start date and estimated construction completion date.
- 17. Label proposed temporary construction signs, barricades, delineators, flaggers, etc.
- 18. Label proposed taper lengths, width, and delineator spacing.
- 19. Label signs/barricades to navigate bicyclists and pedestrians around the Work Zone.
- 20. Label any proposed temporary parking restrictions.
- 21. Copy the following General Notes onto the TCP.

### **Traffic Control Plan General Notes:**

- All traffic control devices shall conform to the latest edition of the California Manual on Uniform Traffic Control Devices (MUTCD).
- 2. Work hours are 8:00 am 6:30 pm Monday-Friday, and 8:00 am to 5:30 pm on Saturdays.
- Any night work will require prior written approval from the Community Planning & Building Department.
- 4. The contractor shall maintain traffic control devices 24 hours per day, 7 days per week.
- 5. Traffic control devices shall be removed from view when not in use.
- 6. Travel lanes through construction sites shall be at least 12 feet wide.
- 7. Temporary "No Parking" signs must be posted at least 48 hours prior to work.
- 8. Open trenches must be backfilled or plated during non-working hours.
- 9. A flashing arrow board is required prior to the taper for arterial lane closures.
- 10. Workers shall wear visibility vests in the day and reflective vests at night.
- 11. Flaggers shall be trained in the fundamentals of flagging traffic and equipped with a vest, hard hat, and C-28 "Stop/Slow" paddle.
- 12. TCPs for construction work along an arterial street or within the downtown business district shall be signed and stamped by a registered Civil Engineer or Traffic Engineer.
- 13. Road closures and detours require prior written approval by the Director of Public Works.
- 14. The Director of Public Works, Director of Public Safety, or designee, are authorized to order changes to assure public safety.

# PG&E Urges Customers to Always Call 811 to Avoid Damaging Utility Lines in Carmel-by-the-Sea

CARMEL-BY-THE-SEA, Calif. — With spring's warmer weather comes an abundance of presummer outdoor projects that require digging. To prevent damage to underground utility lines in Carmel-by-the-Sea, Pacific Gas and Electric Company (PG&E) urges customers to call 811 before starting any project that involves digging.

"Whether you are planning to do it yourself or hire a professional, you should always call 811 before each job to have underground utility lines marked," said Rob Morse, senior manager of PG&E's Central Coast division. "It's a free and easy service that protects public safety and helps avoid damage to utility lines, service interruptions and fines."

Last year, there were more than 1,735 strikes on PG&E's underground infrastructure – six of them in Carmel-by-the Sea. This year, the city has experienced two dig-ins. Fencing, water and sewer projects are the top three activities that have resulted in underground utility strikes in Carmel. Of the 1,735 strikes in 2016, more than 55 percent had not called ahead to have underground utility lines properly marked. The average cost to those who damaged PG&E's underground utility lines, including fines and repairs, amounted to \$7,500.

## About the 811 Free Safety Service

811 is a free nationwide service that sends utilities to mark the location of underground lines, including gas, electric, water and fiber optic services. Underground Service Alert (USA) North, which operates 811 in PG&E's service area, created 811express.com to reduce demand to the 811 call line and provide a convenient way for the public to request utility markings.

Homeowners and contractors can prevent gas leaks and power outages while protecting themselves and the safety of their community by requesting a USA ticket. Contractors are required by law to contact 811 at least two working days prior to excavation, but any digging project requires a USA ticket, including planting a tree or setting posts for a picket fence.



## **Public Works General Conditions of Approval**

- 1. Carmel-by-the-Sea to file CEQA Negative Declaration with the County of Monterey.
- 2. Pipeline Alignment: As-built or redline drawings shall be submitted to the City prior to acceptance of the surface improvements showing offsets of the centerline of the 8" pipeline from the face of curb or centerline of street along each street segment.
- 3. Blow Off Valves: Obtain prior City approval for placement or relocation. Fire hydrants to be color-coded per NFPA. (Ok. Fire hydrants painted by the Fire Department.
- 4. Air Release Valves: No ARV's are proposed. Obtain prior City approval if ARV's are required.
- 5. Pressure Reducing Valves: No PRVs are proposed. Obtain prior City approval if PRVs are required.
- 6. Surface-Accessed Vaults: No surface-accessed vaults are proposed. Obtain prior City approval if surface-accessed vaults are required.
- 7. Public Relations: CalAm shall implement the following outreach program as a minimum during construction of the Dolores Street Main Replacement:
  - a) Project shall be presented at City Council Meeting prior to approval, in addition neighborhood meetings throughout the project phases might be required.
  - b) Door hangers and notices
  - c) Project barricades shall identify Project name and include Project owner contact information.
  - d) Magnetic truck signs (optional)
- 8. Council Meeting/Study Session: Cal Am to make additional presentations to the City Council upon request.
- 9. Joint Utility Coordination Meetings: Cal Am to continue to attend and present updates at bi-monthly Joint Utility Coordination Meetings.
- 10. Plan Checking: During construction of the Dolores Street Main Replacement, the City will provide plan checking services for: revisions to traffic control plans, ADA ramps, relocated sewer laterals, relocated sewer and storm drain pipelines, intersection modification plans, and street and sidewalk improvements that cannot be reconstructed to meet preconstruction conditions in accordance with ADA standards, due to utility conflicts or similar reasons.
- 11. Construction Inspection: Quality Control (QC) Inspection shall be performed by Cal Am or Cal Am's contracted inspector, CM Works. The City's inspections, whether by City staff, consultants, testing services, or combination, is intended for Quality Assurance (QA) purposes. City requests copies of all QC inspection daily inspection reports for each heading,

- and all QC materials testing results performed by independent firm under the Contractor. City will make City's QA inspection reports and materials testing reports available to Cal Am upon request.
- 12. Right-of-Way: Provide evidence to the City of any right-of-entry permits and/or temporary or permanent easements on private properties within City limits.
- 13. Permits (Other): Provide City with a copy of the following permits obtained for this Project:
  - a) California Department of Health Services Office of Drinking Water Variance for Water/Sewer line separation requirements if applicable.
- 14. FY 2021/2022 Pavement Rehabilitation Program: While no conflicts are anticipated, the City and Contractor will meet in good faith to determine a resolution which minimizes impacts to both projects.
- 15. Potholing: Pothole data shall be incorporated into As-Built/Red Line set.
- 16. Key City Events: Cal Am's External Affairs Manager and City's Communications Officer to coordinate during construction and advise construction team of upcoming events. City to provided listing of key City Events, and Contractor will make good faith efforts to reduce public inconvenience during City events.
- 17. Water Valves: All water valves located within paved City streets shall be replaced in accordance with Cal AM Standard Drawing No. 4, including installation of new G-5 Valve Box and Cover with Metal Lid Marked "Water."
- 18. Conformed Plans: Provide City with two (2) full size and two (2) half size sets of conformed plans and four (4) copies of the specifications with all appendices prior to the start of construction at no cost to City. See #38, Potholing.
- 19. Prior to issuance of a building permit, the applicant shall submit a completed BMP Tracking form for review and approval by the City of Carmel. Best Management Practices shall be implemented and in place prior to any construction operation being initialized.

## **Forestry Comments/Conditions**

20. Street Trees: No trees are to be removed under this Permit. Contractor's arborist to contact City Forester at (831) 877-0949 for site consultations prior to trimming any canopy or roots of any City tree. Any trees damaged by Contractor's operations shall be replaced and maintained for a period for up to five (5) years as required by the City Forester. (Roots no larger than 2 inches shall not be cut without approval by CAW or City Forester.) (It was discussed that CAW and City arborist will walk the project prior to start of construction to identify potential concerning areas or tree locations.

#### CITY OF CARMEL BY THE SEA CONTRACTOR CONDITIONS:

- 21. Blow off discharges: discharges are not permitted into the city's storm drain system, including into lakes or streams. This applies to construction water and future operations of the pipeline. Discharges into the sanitary sewer system require prior approval of the Monterey regional water pollution control agency (MRWPCA), CAWD, and the city.
- 22. Street trees: no trees are to be removed under this permit. Contractor's arborist to contact city forester at (831) 877-0949 for site consultations prior to trimming any canopy or roots of any city tree. Any trees damaged by contractor's operations shall be replaced and maintained for a period of up to five (5) years as required by the city forester. Roots no larger than 2 inches shall not be cut without approval by CAWD or City Forester. Caw and city arborist will walk the project prior to start of construction to identify potential concerning areas or tree locations.
- 23. Staging areas: provide to the city legal evidence of the use of all staging area(s) located within city limits.
- 24. Haul roads: haul roads will follow pipeline alignment and approved traffic control plans to the extent possible. Deviations require prior approval of the city.
- 25. Cross gutters: restore cross gutters per city standard. Cross gutters are to be reconstructed from spandrel to spandrel.
- 26. Striping/markings: existing signs, striping, pavement legends, and markings will be restored to current city standards and as directed by the city. Provide temporary pavement markings and striping on arterials in accordance with MUTCD and Caltrans standards. Provide permanent striping, legends, and markings within ten (10) business days of permanent pavement restoration. City to provide specifications on painting, striping, and markings.
- 27. Parking notices, tees and stalls: provide a minimum of 72-hour advance notices for no parking zones every 50 feet in each direction affected. Restore parking tees per city standard detail. Parking notices will indicate the start date and anticipated duration of work within the affected area. Coordinate no parking zones with public works, (831) 620-2070.
- 28. Crosswalks: restore crosswalk striping per city standard regardless of existing condition.
- 29. Ingress, egress, and parking impacts: notify, coordinate, and resolve access, ingress, egress, special needs (disabilities), and parking issues with all private property owners/tenants and businesses along the pipeline route. Contractor to always provide access to residents.
- 30. Incomplete street openings (barriers and steel plates): where street openings cannot be backfilled during the day of opening, suitable barriers shall be placed around the excavation to prevent accidents, and lighted barricades shall be continuously maintained at the opening site. Alternatively, steel plates may be placed over or flush with the trench if traffic would otherwise be impeded. Steel traffic plates may be used at the end of trench in order to start work the following day without having to re-excavate the trench. No more the two steel plates shall be

used at the finishing end of trench. Trench plates along arterials shall be flush with adjacent asphalt pavement; however, this requirement is waived within concrete pavement.

Temporary trench repair: all streets shall be temporarily restored with either cold mix or hot mix asphalt (HMA). The temporary trench patch must be kept in good condition with a reasonably smooth riding surface until structural pavement restoration. If cold mix asphalt is used, at the discretion of both the city and caw, the contractor may be required to pave the initial half of the alignment with HMA if the conditions or required maintenance of cold mix asphalt continues to be an issue.

The temporary trench repair asphalt shall be removed prior to structural pavement restoration. Asphalt replacement shall extend 1' beyond trench cut on each side of the trench. Where gutter edge or nearest lane line is less than 3' from trench limit, pave merit shall be replaced to gutter edge or to nearest lane line. When adjacent trenches are less than 3' from edge to edge, asphalt between trenches shall be removed and replaced. Additional pavement beyond the trench limits will be evaluated with site inspections if damage from construction to surrounding pavement occurs. The structural pavement restoration will be paved to a depth of at least 1" greater than existing pavement thickness.

Final surface restoration: within three (3) months of pipeline completion, or as otherwise agreed to by the city, all streets along the pipeline alignment shall be completed with final resurfacing (gutter to gutter, or curb to curb). Preference will be given to pave/resurface long segments of streets at one time. Areas of defective pavement shall be removed and replaced prior to resurfacing in coordination with city inspection and city standards. Pavement resurfacing shall be slurry type ii on residential streets and slurry type iii on all collector and arterial streets. Slurry mix designs to be pre-approved by city.

- 31. Contractor to avoid trenching or work that would trigger ADA ramps. Contractor shall contact caw and the city if there are any questions or concerns about which work could trigger ADA ramps.
- 32. Concrete pavement section: all concrete trenches/patches to be doweled with #4 rebar, 2 feet on center and epoxied. Concrete mix design to be pre-approved by city.
- 33. Prior to issuance of a building permit, the applicant shall submit a completed bmp tracking form for review and approval by the city of Carmel. The contractor shall implement the best management practices and have them in place prior to any construction operation being initialized. Bmp details have been added to the contract documents. Contractor responsible for any additional measures that may be required for this project, or to obtain approval by the city.
- 34. Environmental mitigation: city requests a copy of all reports, surveys, logs, and records.
  - A) cover all trucks hauling soil.
  - B) sweep all paved access roads daily.
  - c) enclose or cover daily exposed stockpiles.
  - D) the city may request reasonable technical support from the qualified biologist.

- E) trees and vegetation not planned for removal or trimming shall be protected in place prior to construction.
- F) on-site spill containment measures shall be available at all work headings.
- G) in addition to other required notifications, "contractor" shall also promptly notify caw and the city of any archaeological findings in the event any are encountered. All excavating is to cease immediately.
- H) in addition to other required notifications, "contractor" shall also promptly notify caw and the city of findings of any human remains in the event any are encountered. All excavating is to cease immediately.
- I) night time work is not permitted.
- J) designate worker parking areas that minimize parking displacement, and review worker parking strategies with city.
- 35. Project schedule: provide city a construction "3 week look ahead" schedule on a regular basis. In lieu of a weekly construction schedule, a detailed project schedule will be required on at least a monthly basis.
- 36. Protection: trench compaction shall be limited to the use of a compactor in a manner that induces an external load at the point of compaction of no greater than 2,450 psf at the following locations:
  - Locations where city utilities (storm drain and sewer only) are found to be located within 6'-5" of the outside diameter of the pipeline (i.e. based on USA markings and/or potholing), and
  - All crossings where the existing sewer is located below the pipeline trench.

in lieu of a compactor, the contractor may backfill the trench with city-approved cement slurry. Sewer lateral repairs: existing sewer laterals damaged during construction will be repaired as soon as reasonably possible. Leaks as a result of the damaged pipe and/or repair shall be contained on site and disposed of in a lawful manner. All lateral connections will be made by the installation of a "wye" (y) and a straight piece of pipe. Repairs to be made by contractor and in accordance with CAWD requirements if damaged during construction.

- 37. Blow off valves: obtain prior city approval for placement or relocation.
- 38. Fire hydrants to be color coded per NFPA. Cal-am will flow test and determine flow capacity and color coding. Contractor to paint fire hydrant caps.
- 39. Air release valves: no ARV's are proposed. Obtain prior city approval if ARV's are required.
- 40. Pressure reducing valves: no PRV's are proposed. Obtain prior city approval if PRV's are required.
- 41. Surface accessed vaults: no surface accessed vaults are proposed. Obtain prior city approval if surface accessed vaults are required.
- 42. Contractor shall hang door hangers and notices.

- 43. Contractor to provide project barricades with project name and include project owner contact information.
- 44. Potholing: pothole data shall be incorporated into As-built/red line set.
- 45. Water valves: all water valves located within paved city streets shall be replaced in accordance with CalAm standard drawing no. 4, including installation of new g-5 valve box and cover with metal lid marked "water."
- 46. Emergency contacts: contractor to provide a list of at least three (3) names of 24/7 emergency contacts who can respond to accidents, traffic control and trench restoration issues. In addition, CalAm shall furnish and maintain an updated, comprehensive list of all project stakeholders, to include primary and alternate contacts, including CalAm, engineer of record, Caltrans, PG&E, AT&T, Comcast, city of Carmel by the sea, and other key stakeholders.
- 47. Construction work hours: night time work under this permit is not allowed. All other work is to be completed within the hours of 8:00 am -5:00 pm, Monday through Friday. If after hours, weekend, or holiday work is requested, prior authorization must be granted by the city. The city will charge an additional fee for all the work occurring outside of standard working hours.
- 48. Relocated utilities: while no relocations of city facilities are anticipated at this time, if necessary, they will be properly planned, designed, and coordinated in advance of construction as a result of potholing. In the event that an unforeseen condition during construction requires the prompt realignment or relocation of an existing city utility or facility (i.e. sewer or storm drain pipe, drainage inlet, traffic signal pull box), the contractor/engineer of record shall provide sketches of both the existing condition and proposed condition in plan and profile, along with photographs and the improvement plans illustrating the exact location. A meeting will be held at the site, or a phone conference will be held as soon as possible. Upon the city's assessment and approval, the work may proceed. The relocated facility will be shown on the as built plans. In the event of an emergency where immediate repairs are warranted, contractor/engineer of record shall make a good faith effort to contact the city prior to making emergency repairs.
- 49. Traffic control plans: TCP's for the 8" water main installation will be submitted for review and approval by the city. TCP's must be approved by the city for a minimum of two (2) weeks prior to construction of the 8" pipeline along that street segment. Additional or modifications to approved traffic control plans must also be approved by city prior to construction along the affected street segment. A preliminary TCP was provided to the city by caw. Final TCP to be provided by contractor.
- 50. Pedestrian/bicycle detour plans: provide safe provisions for pedestrians and bicycles around construction zones as required by the city.
- 51. Hazardous materials: handle, treat, and/or dispose of hazardous materials per specifications sections 01150 and 0220 or as otherwise directed by the regulatory agency having jurisdiction.
- 52. Preconstruction video: contractor to provide CAWD and City with an indexed (by street address), preconstruction video of existing surface improvements shown from both directions, of

- acceptable clarity and quality to the city. In addition, provide copy of preconstruction photographs of specific locations within two (2) business days as requested by city.
- 53. Survey monuments: survey monuments removed or damaged due to construction operations shall be restored by a licensed land surveyor. All survey monuments located within the trench patch shall be replaced in accordance with city standard.
- 54. U.S.A. notification: at least two (2) days before any excavation, contractor must contact underground service alert at 1-800-227-2600.
- 55. Cutting street surfaces: all concrete and asphalt streets, and concrete and asphalt sidewalks, curbs, gutters, medians, and dikes, will be saw cut with smooth straight edges unless otherwise approved by the city.
- 56. Headings: no more than one (1) pipeline heading is permitted on this project at one time within the city limits without prior approval from the city.
- 57. Clean up of right of way: upon completion of work along a street segment, all materials, traffic control devices, scraps and other materials and debris shall be entirely removed and the right of way left in a condition satisfactory to the city.
- Damage to existing facilities: promptly make repairs to the public right-of-way or underground utilities that are damaged by the work authorized by this permit. Damage to city streets outside of the pipeline alignment caused by construction operations, and specifically including haul routes, shall also be repaired to pre-construction conditions. These repairs shall be to the satisfaction of the city. Damage to third party utilities shall be repaired as required by the applicable utility's owner.
- 59. Storage of materials: absolutely no stockpiling of material will be allowed along the sidewalk or on private property. Stockpiling along the street must be contained within the barricaded/ protected areas of work site as approved by the city. No stockpiling shall be located in the street gutter pan or drainage path.
- 60. Concrete washout locations: locations must be pre-approved by the city.
- 61. Emergency access: always maintain access for emergency vehicles.
- 62. Emergency response notifications: contractor shall notify police and fire (831) 624-6403, and ambulance service providers at least 48 hours in advance as to proposed road/lane closures, detours, and alternate routes available.
- 63. School zones: avoid truck trips through designated school zones during school drop off and pickup hours. Provide construction schedule updates to the schools for bus route coordination.
- 64. Road closure notifications: notify postal carrier, transit lines, trash collectors, school districts and affected residences and businesses at least 48 hours in advance as to proposed closures and alternate routes available.
- 65. Private improvements: restore, repair, or replace private property improvements damaged by construction operations to the pre-construction conditions as commercially practical and to the

private property owner's satisfaction. In the event the private property owner is not satisfied with the restoration or repair of damaged improvements, CalAm's external affairs manager, construction manager, and/or other such representative shall meet with the property owner to resolve the issue.

- 66. Construction progress meetings: city expects to be invited and be able to actively participate in stakeholder construction progress meetings. Regardless of attendance, the city shall receive copies of progress meeting agendas and meeting minutes.
- 67. Construction correspondence: city requests to be copied on project correspondence, submittals, RFI's, etc. Pertaining to restoration of surface improvements within the city limits.
- 68. Final inspection: prior to a final inspection, all surface improvement work must be approved to the satisfaction of the city in accordance with applicable specifications and standards.
- 69. Insurance: permit holder shall furnish a certificate of insurance showing there is in force the following valid policy showing the permit holder as the named insured and showing: a) commercial general liability-a minimum \$5,000,000 combined single limit per occurrence for bodily injury and property damage including products and completed operations, and 2) workers compensation and employers liability; limit of not less than \$1,000,000 per accident as required by the labor code of the state of California. Permit holder hereby waives any rights of subrogation against the city respecting worker's compensation. Commercial general liability certificate must be accompanied by the following endorsements: 1) the city of Carmel by the sea, its officials, officers, directors, employees, agents and volunteers (hereinafter "city covered parties") are named as additional insureds; 2) notice of cancellation or changes of coverage shall be given to the city. The insurance is primary insurance with respect to the city covered parties. Any other insurance the city may have shall be considered excess insurance only. Permit holder's insurance shall also include a separation of insured's provision so that permit holder's insurance shall apply separately to each insured against whom liability is asserted. Failure of the contractor to obtain and maintain the insurance as noted above may cause the denial and/or revocation of the contractor's permit, at the sole and absolute discretion of the city.
- 70. Business license: contractor is required to possess or obtain a city of Carmel-by-the-Sea business license prior to the start of work.

SUBJECT: Tree Service Contractors to include prior tree-related budgeted items totaling

\$200,000 in addition to a \$200,000 mid-year budget allocation

## RECOMMENDATION:

Adopt Resolution 2024-023 approving Change Orders #3 for each of the City's On-Call Tree Service Contractors to include prior tree-related budgeted items totaling \$200,000 in addition to a \$200,000 mid-year budget allocation.

## BACKGROUND/SUMMARY:

In March 2023, Council awarded multi-year On-Call Tree Service Contracts to Community Tree Service (CTS), Tope's Tree Service (Topes), and West Coast Arborists (WCA) to perform a variety of tree services, predominantly removals of large dead or dangerous trees, prune or remove trees near powerlines, tall tree pruning, stump removals, and emergency storm recovery. The contracts also include other on-call services such as arborist services, tree planting, watering, and invasive removals.

Due to unprecedented storms in early 2023, Change Orders #1 to all three contractors were approved by Council in June 2023 to "true up" expenditures during Fiscal Year (FY) 2022/23. Change Orders #2 were also approved in June 2023 to initiate budgets for FY 2023/24. The original contract amounts and amounts for Change Orders #1 and #2 are tabulated below.

The initial budget for FY 2023/24 under Change Orders #2 of \$525,000 did not account for other work identified in the FY 2023/24 Adopted Budget. Specially, \$125,000 was reserved for storm response, and \$75,000 was budgeted in the Operating Budget, rather than in the Capital Improvement Program, for tree

work in the Mission Trail Nature Preserve. The total tree services-related budget was therefore \$725,000. Keeping some funds in reserves allowed the City broader flexibility in allocating the remaining \$200,000 not yet under contract. However, following the winter in February 2024, Forestry issued Task Orders for all but \$33,000 of the above-mentioned \$725,000 for tree-related contract services.

As part of the Mid-Year Budget Adjustments at the March 5, 2024 meeting, Council authorized an additional allocation of \$200,000 for additional tree-related services to continue addressing the backlog of City tree and stump removals for the remainder of FY 2023/24.

The combined total amount of Change Orders #3 is \$400,000, which consists of the \$125,000 in storm reservices, \$75,000 for MTNP work, and \$200,000 from the Mid-Year Budget augmentation.

Upon Council approval of Change Orders #3:

- Community Tree Service's contract for FY 23-24 will increase from \$175,000 to \$325,000.
- Tope's Tree Service's FY 23-24 contract for FY 23-24 will increase from \$175,000 to \$350,000.
- West Coast Arborists FY 23-24 contract for FY 23-24 will increase from \$175,000 to \$250,000.

## **Environmental Evaluation**

This action does not constitute a project within the meaning of the California Environmental Quality Act under Public Resources Code Section 21065. It has no potential to cause either a direct physical change in the environment or a reasonably foreseeable indirect physical change in the environment and, therefore, does not require environmental review.

## FISCAL IMPACT:

Sufficient funding is available in the Public Works Department/Forestry Contractual Services Account #101-119-45-42001 to cover the amounts in Change Orders #3.

## PRIOR CITY COUNCIL ACTION:

In March 2023, Council awarded multi-year On-Call Tree Service Contracts to Community Tree Service, Tope's Tree Service, and West Coast Arborists with initial budgets for FY 2022/23. In June 2023, Council approved Change Orders #1 to true up expenses for FY 2022/23, and approved Change Orders #2 to set an initial budget for FY 2023/24 for each of the contractors at \$175,000.

In March 2024, Council approved a Mid-Year Budget Adjustment of \$200,000 for additional tree services for the remainder of FY 2023/24.

WHEREAS, in March 2024, Council approved a Mid-Year Budget augmentation of \$200,000 to continue addressing the backlog of tree-related services for the remainder of Fiscal Year 2023/24; and

WHEREAS, Change Orders# 3 will allocate the remaining \$400,000 total to the three On-Call Tree Service contractors to cover the remainder of the 2023/24 Fiscal Year.

## NOW THEREFORE, BE IT RESOLVED THAT THE CITY COUNCIL OF THE CITY OF CARMEL-BY-THE-SEA DOES HEREBY:

Approve Change Orders #3 to the On-Call Tree Services Contracts for the remainder of Fiscal Year 2023/24 as follows:

- Tope's Tree Service Increase Fiscal Year 2023/24 budget of \$175,000 by \$175,000 for a total of \$350,000
- West Coast Arborists Increase Fiscal Year 2023/24 budget of \$175,000 by \$75,000 for a total of \$250,000
