#### **OLD BUSINESS**

Commander Trayer presented the information to the Committee. The committee reviewed a request for no parking signs on Santa Rita, southeast of Ocean Avenue. The committee had visited the site and have seen the parking situation, and the difficulty getting out of the driveway across the street from the No Parking poles, when people are parking south of the No Parking pole.

Dear Brandon,

Nice talking to you earlier this week during the Special Council Meeting.

As I mentioned, I would like to thank you and the Traffic Safety Committee members, for placing a Pedestrian Crossing sign at the bottom of the Jane Powers Walkway. It is a considerable improvement.

However, I would like to add a few additional suggestions and reinstate the importance of a marked crosswalk path at the end of the Jane Powers walkway for crossing North San Antonio Street between  $2^{nd}$  and  $4^{th}$  Avenues.

First and foremost, the signs are nice (see pics) yet they are only on one side. There should also be signs on the sidewalk across San Antonio to allow the drivers coming from 4<sup>th</sup> Ave on San Antonio towards the Pebble Beach gate to see you. The street curves a bit there so the sign facing them cannot be seen until you are quite close to the crossing area.

Secondly, the signs are a great improvement but we still need to have the marked crosswalk to:

- 1. Offer better visibility of pedestrians when crossing from the Jane Powers walkway to the San Antonio Street sidewalk.
- 2. Allow people with strollers to be seen and ensure they can cross slowly to the San Antonio sidewalk.
- 3. Slow down drivers going north from 4<sup>th</sup> Ave into the Pebble Beach access gate on 2<sup>nd</sup> Ave. Drivers accelerate as they come around and have poor visibility of pedestrians waiting to cross.
- 4. Slow down drivers coming south from 2<sup>nd</sup> Ave since there is no stop sign coming out of Pebble Beach.
- 5. It will make drivers attentive to pedestrians and stop for them. Same as we have all along Scenic Rd.

I appreciate you giving this additional consideration and I hope we can have a crosswalk soon.


Please bring the 4 way stop study back to traffic committee and then to city council.

Also the usps parking lot is being used on Saturday when residents need it to collect mail. And the stripping on corner and an additional stop sign in the ne corner needs to be considered seriously.

Another issue is that cars and trucks are starting to park in and on the junipero medians between 8th and 12th. More no parking signs are needed. This will be especially important as more remodels occur in that stretch.

And lastly, there have been e-bikes and motorcycles seen in mtnp. This is eroding trails and endangering walkers. We probably need an ordinance prohibiting bikes on Martin meadow and smaller walking trails.
